These rules shall govern the procedure in the superior and district courts of the State of North Carolina in all actions and proceedings of a civil nature except when a differing procedure is prescribed by statute. They shall also govern the procedure in tort actions

### Chapter 1A - North Carolina General Assembly

Beginning April 22, 2020, in accordance with 20-SO-5 and at the direction of the Court, all intake counters in the Eastern District of North Carolina will be open to the public from 1:00 p.m. to 3:00 p.m., Monday through Friday. A file drop box is located at the courthouses in Greenville, New Bern, Raleigh, and Wilmington for filings during the hours when the intake counters are closed but the buildings are open to the public.

NC General Statutes - Chapter 8C 2. (a) Questions of admissibility generally. - Preliminary questions concerning the qualification of a person to be a witness, the existence of a privilege, or the admissibility of evidence shall be determined by the court, subject to the provisions of subdivision (b).

The date of original approval of the Rule by the North Carolina Supreme Court is identified as the "Adopted" date. Under North Carolina General Statutes Chapter 28A, the Clerk of Court has authority to compel anyone in the state to produce the will. For the first 60 days after the decedent's death, the named executor is the only person authorized to file the will with the Clerk of Court.
